I hereby release Immerse Lincoln and the Kingdom Enterprise Zone (KEZ) of SE Nebraska, and all associated parties, including any churches or organizations which they are partnering with, from all claims and liabilities of any kind, whether known or unknown, which arise from or are connected in any way with my/my child's participation in this trip. I fully recognize that I/they will be serving in various sites where I/he/she may be exposed to various unforeseen risks.

If for any reason I/my child is unable to complete my/his/her stay at the project, I assume full responsibility for the expenses incurred for my/his/her return home. I am also aware that any lack of respect for authority, including the use of abusive language, violations of site smoking policies, and failure to comply with behavioral expectations may result in me/his/her being sent home at my expense. I understand that any use or possession of alcohol, firearms, weapons, or drugs (not prescribed by a physician) will automatically result in my/his/her being sent home at my expense.

In the event of an emergency, I hereby authorize a leader of this activity, as an agent for me, to consent to: any x-ray examination, medical, dental or surgical diagnosis; treatments; hospital care advised and supervised by a physician, surgeon or dentist (as appropriate) licensed to practice under the laws of the state or country where services are rendered, either at a doctor's office or in a hospital. I expect my emergency contact/I will be contacted as soon as possible.

I understand that this document constitutes a full and complete waiver of all possible claims, including claims of negligence, arising out of my/my child's participation in the trip. I also agree that I will defend, indemnify, and hold harmless the parties released from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney fees, brought as a result of my or my child's participation in the trip, even if the damages or injuries are caused in whole or in part by the released parties.

I understand that this release applies to, covers and includes unknown, unforeseen, unanticipated, and unsuspected damages, losses or liabilities and the consequences thereof, which result from the matters herein before inferred to as well as those now disclosed and known to exist. The provisions of any state, federal, local, provincial or territorial law or statute providing in substance that releases shall not extend to claims or damages which are unknown or unsuspected to exist at the time are hereby expressly waived by me.
